Korean Canadian Scholarship Foundation (KCSF) bursary awards are meant to help students overcome financial difficulties or other unforeseen expenses. Bursary applications are considered by the KCSF Bursary Selection Committee. Awards are **\$1,000** each. Students cannot receive more than one bursary award in an academic year.

IMPORTANT GUIDELINES

- **All** sections of the application **MUST** be completed. Please type your answers in the boxes provided.
- Incomplete applications will **not** be considered by the committee.
- Applicants must be a Canadian Citizen, a Landed Immigrant, or a Visa Student.
- Students must be enrolled full-time during the 2011-2012 academic year in order to receive a bursary. Applicants must provide proof of registration and tuition payment at a post-secondary institution (e.g University or College).
- If you have not applied for a Canadian Student Loan and Provincial Student Loan, an explanation of the reason must accompany the application. If you are not eligible for either Canadian or Provincial Student Loans, please enclose the non-eligibility letter from the government (Visa Students do not need to enclose the non-eligibility letter).
- You must include copies of your T1 Personal Tax Return for the past year along with the corresponding Notice of Assessment from the Canada Revenue Agency. If you did not file a tax return, please state the reason why.
- The deadline for the KCSF bursary application is **Wednesday November 30, 2011**.
- The bursary process takes approximately **SIX to EIGHT** weeks.
- Please note that a letter will be sent to all students indicating the outcome of their bursary application.
